Procurement of Furniture for the Belize Bureau of Standards

1.0 Background

The programme "Technical Barriers to Trade" (TBT) is one component of the 10th European Development Fund – Caribbean Regional Indicative Programme – Economic Partnership Agreement (10th EDF-CRIP-EPA) Programme called "Support to the Caribbean Forum of the ACP States in the implementation of the commitments undertaken under the Economic Partnership Agreement".

The overall objective of the 10th EDF Programme is to support the beneficial integration of the CARIFORUM States (i.e. CARICOM and the Dominican Republic) into the world economy and in that line the overall objective of the "Technical Barriers to Trade" programme is to facilitate intra- and interregional trade as well as international competitiveness and sustainable production of goods and services within the CARIFORUM States for the enhancement of social and economic development.

The specific objective of the "Technical Barriers to Trade" programme is to increase the use of services of internationally recognised Regional Quality Infrastructure Institutions in the CARIFORUM States.

The expected result is to progress towards achieving a modern regional and national quality infrastructure (QI) according to internationally-recognised principles for international trade as defined in the World Trade Organisation (WTO) Agreement and the TBT Chapter of the EPA. This result aims to address the problem of lack of regional/national "Quality Infrastructure" to facilitate and ensure compliance with technical regulations of international trade partners and with international standards and conformity assessment procedures, thereby strengthening the region's international competitiveness and sustainable production of goods and services within the CARIFORUM States. The availability of measurements that are traceable to the International System of Units (SI) provided by international recognised calibration laboratories will help to assure that test results and certificates are accepted in regional and international markets.

The 10th EDF Programme is currently supporting the Belize Bureau of Standards in improving its measurement infrastructure with particular focus on complementing the recent construction of the new metrology laboratories. It is expected that these new laboratories will support the development of Belize by providing traceability of measurements to the International System of Units as well as technical assistance to developing National Metrology Institutes.

2.0 Specific Purpose

This intervention is geared towards furnishing the Fine Mass, Grand Mass, Temperature and Volume Metrology Laboratories at the Belize Bureau of Standards located in Belmopan, Belize.

3.0 Project Objective

The **objective** of the engagement is to supply select furniture for the Fine Mass, Grand Mass, Temperature and Volume Metrology Laboratories at the Belize Bureau of Standards.
