3. FUNCTIONAL RELATIONSHIPS

Works under the direction of the Deputy Executive Director (DED). Collaborates with the staff of the Resource Management and Administration Division (RMAD) and the Alliance and Cooperation Services (ACS) Unit and other staff of the Coordinating Unit (CU).

4. SUMMARY

The Programme Manager, Response and Recovery (PMRR) will be required to provide technical and strategic leadership in response and recovery program design, implementation and monitoring at the CDEMA Coordinating Unit (CU). This is underpinned by the recognition that effective response and recovery are founded on solid preparedness. The PMRR will also be responsible for the development and implementation of contingency planning initiatives in support of the Regional Response Mechanism (RRM).

5. DUTIES AND RESPONSIBILITIES

- 5.1. Establish mechanisms for the undertaking of regular audits of national and regional readiness, the analysis of the results and the reporting to and through the ED to PS and organs of the agency
- 5.2. Utilize the results of the audit analysis to prepare programming priorities and strategic response and recovery planning.
- 5.3. Oversee the enhancement, coordination and review of the regional search and rescue programme
- 5.4. Ensure the operational Readiness of the CU
- 5.5. Ensure the continued enhancement and dissemination of an up to date regional response coordination plan.
- 5.6. In consultation with the ED, coordinate the response activities of the CU Regional Coordinating Centre (RCC) during activation
- 5.7. Develop maintain and exercise regional coordination plans and Standard Operating Procedures (SOPs) for the CDEMA CU in collaboration with stakeholders

- 5.8. Establish and maintain programmes for the Management, training and deployment of the CARICOM Disaster Relief Unit (CDRU) in collaboration with appropriate regional partners
- 5.9. Establish, maintain and regularly review mechanisms for accessing and coordinating the deployment of response personnel from CDEMA CU, Participating States and partners to an affected State through the Regional Response Mechanism
- 5.10. Enhance and/or promote strategic and operational partnerships in support of the CDEMA RR Programme and operations management.
- 5.11. Oversee the agency's Early Warning Systems initiatives and collaborate with lead technical agencies to ensure the establishment and maintenance of Early Warning Systems (EWS) for critical hazards affecting the CDEMA Participating States
- 5.12. Enhance and maintain a programme to strengthen capacity in recovery planning at all levels of the CDEMA system.
- 5.13. Collaborate with the Alliance and Cooperation Services (ACS) Unit in the development and promotion of capacity building services in Business Continuity for public and private sector actors.
- 5.14. Review the socio-economic and political environment and the disaster risk and institutional context of Participating States with a view to providing advisory services, including the concept framework for project proposals in the areas of response and recovery.
- 5.15. Supervise staff as assigned to include the timely establishment of performance plans and the conduct of performance assessments.
- 5.16. Prepare and submit monthly and other reports as requested.
- 5.17. Lead the disaster response activities of the Agency, as may be required
- 5.18. Perform any other duties as may be directed from time to time by the Deputy Executive Director or any duly authorized officer of the Agency.

6. CONDITIONS

- 6.2. Position may require periods of travel to CDEMA Participating States as well as other destinations.
- 6.3. Institutional support provided through documented rules and regulations general policy guidelines and through access to available relevant information, resources and facilities
