# Relief Supplies Continue to Arrive in Jamaica from the Caribbean Regional Logistics Hub

## **OVERVIEW**

The Dutch naval vessel HNLMS Pelikaan (A804) arrived in Kingston Harbour today, November 4th, carrying 648 cubic metres of humanitarian relief supplies to support ongoing recovery operations in Jamaica following Hurricane Melissa. The shipment, coordinated through regional and international partners, includes critical items addressing early recovery, shelter, logistics, health, and water, sanitation and hygiene (WASH) needs. The relief consignment was jointly provided by the Department of Emergency Management (DEM) Barbados, the Pan American Health Organisation (PAHO), ShelterBox, the United Nations Children's Fund (UNICEF), and the World Food Programme (WFP). Upon completion of offloading operations, the HNLMS Pelikaan is scheduled to return to Barbados to transport a second shipment of relief supplies.

The Executive Director of CDEMA, Elizabeth Riley, met with The Honorable Desmond Mckenzie, Minister of Local Government and Community Development in Jamaica, Marsha Henry-Martin, Permanent Secretary in the Ministry of Local Government and Community Development and Regional Response Mechanism (RRM) team leads on November 3rd to discuss the status of response efforts in Jamaica and the needs emerging as assessments continue. The CARCIOM Emergency Telecommunications Team (CETT) was deployed to Jamaica on November 3rd, and a two-person team of Mental Health and Psychosocial Support (MHPSS) specialists was deployed today to support the RRM teams on the ground. Regional and international partners continue to mobilise and deliver essential relief items, including food, water, medical supplies, and shelter materials, in close collaboration with Jamaican authorities. The CDEMA Coordinating Unit remains in communication with national and international partners to ensure a coordinated and efficient response.



### **JAMAICA**

### Report from the Office of Disaster Preparedness and Emergency Management (ODPEM) in Jamaica

➤ Initial Damage Assessments (IDA) commenced last week and continued today, November 4th, with at least 409 structures assessed in several parishes including Falmouth, Salt Spring, Lucea, Montpelier, Black River, Little London, Petersfield, and Martha Brae (Figure 3).

- The CDEMA RNAT is deployed and providing support to the Initial Damage Assessment (IDA) process and sectoral needs assessments.
- Search and Rescue (SAR) operations continue under the Jamaican Fire Brigade (JFB) with support from the Jamaica Defence Force (JDF).
- ➤ National Works Agency (NWA) is actively clearing roads which are critical for gaining access to isolated communities and improving aid distribution. Helicopter support is being used where access challenges persist.
- ➤ Relief distribution ongoing through the Ministry of Labour and Social Security, Jamaica Red Cross, the World Food Programme (WFP), and Food for the Poor.
- > Coordination ongoing for humanitarian shipments with logistical support from the JDF and the Jamaica Combined Cadet Force.
- Early recovery planning has begun.



### **JAMAICA**




Figure 4: The map illustrates the **3Ws** (Who, What, and Where), as of November 2nd, 2025, showing humanitarian activities across Jamaica in response to Hurricane Melissa. It highlights the number and type of activities by parish, identifying active agencies, sectors of intervention (Health, Logistics, Telecommunications, Food Security, Coordination), and the status of activities (planned or in progress). Major operational areas include Westmoreland, Saint Elizabeth, Saint James, Clarendon, and Kingston.

Humanitarian operations ongoing across Jamaica (Figure 4).

#### Access & Infrastructure:

- Major road damage and blockages, especially in Grand'Anse.
- Three localities near Moron remain cut off; western communes accessible only through Tiburon route (South Department).
- Public Works continues urgent assessments and clearance operations.

#### Health:

- No major infrastructure loss; minor damage to hospitals in Les Cayes, Jérémie, and Port-de-Paix.
- Six injured were treated; psychosocial support provided to 330 children and 75 adults; 54 infants received food assistance.
- Ongoing epidemiological monitoring for waterborne diseases.

### Water, Hygiene & Sanitation (WASH):

- Water shortages reported in Pestel and Cayemites Islands (Grand'Anse).
- 10,000 gallons of potable water, 400 jerrycans, and 20 handwashing stations distributed.

### Agriculture:

 Damage to farmlands, especially in Grand Sud; detailed loss assessment ongoing to guide seed and tool distribution.

### COORDINATION

- Twenty-four (24) persons have been deployed as part of the Rapid Needs Assessment Team (RNAT).
- ➤ Four members of the CARICOM Emergency Telecommunications Team (CETT) have arrived in country and are supporting restoration efforts.
- Two members of the Mental Health Psychosocial Support Services (MHPSS) team have arrived in Jamaica today, November 4th.
- CARICOM Disaster Relief Unit (CDRU) and additional COST representatives are on standby for possible deployment.
- As of November 4th, a total of 56 persons under the Regional Response Mechanism have been deployed to supported Jamacia.

# Updates from the CDPG Thematic Working Groups (TWG) - Actions by the RRM Partners as of 5:00 p.m. on November 4th, 2025



#### **EARLY RECOVERY**

- ➤ In coordination with the Ministry of Education, Skills, Youth and Information, the Early Recovery TWG is on standby to assist once data on priority needs is available; preliminary damage estimates expected by November 7th.
- ➤ UNICEF submitted a request for 30 tents (72mx72 m), and funding to support (i) repairs to 100 schools, and (ii) grants for 500 classrooms.
- ➤ UNICEF continues to share resources via the Learning Passport (LP) platform. The "Be Prepared Disaster Risk Reduction (DRR) Guide" is featured on both the LP and UNICEF Jamaica's Instagram Linktree. The guide is ready for printing as needed. Efforts are underway to update the guide, with a proposed target of 100,000 copies.
- Mental health and psychosocial recovery support ongoing leveraging trained teachers, while expanding F2F and online training to new beneficiaries, and using a Google survey to guide support through the "U Matter" WhatsApp chatline.
- ➤ UNICEF requested 420 School-In-A-Box kits and 420 Early Childhood Development (ECD) kits as part of supplies for recovery, 20 School-In-a Box and 24 ECD kits are in country along with 6 new recreation kits to complement the 380 already distributed across the island by ODPEM. UNICEF has also received a requested surge support in education.
- ➤ CARICOM Development Fund (CDF), United Nations Development Fund (UNDP) Crisis Bureau, UNDP Jamaica, and Planning Institute of Jamaica (PIOJ) are collaborating to develop a proposal tor debris removal. UNDP is positioning to deploy a debris management specialist.
- ➤ Global Emergency Relief Recovery and Reconstruction (GERRR) has been connected with CDEMA to explore coordination with the RNAT.



### **MNCCC**

- > The HMS Trent, positioned off Jamaica, will have its crisis response team meet with PAHO's structural engineer and WASH specialist to jointly conduct the reconstruction assessment of Falmouth Hospital.
- The Port Authority of Jamaica gave the "all clear" for relief vessels to dock in Montego Bay and Falmouth Harbour for the next 4 months.



### **PROTECTION**

- ➤ The UNFPA team met with the Bureau of Gender Affairs today to discuss support for Gender Based Violence (GBV) prevention and response efforts, as the lead of the GBV Sub-Group. This engagement will assist with the overall GBV efforts which will be supported by UNFPA, UN Women and UNICEF.

### **RELIEF & LOGISTICS**

- CDEMA continues an ongoing assessment of maritime and aviation options, both public and private, to support response operations.
- WFP is similarly assessing the viability of a potential logistics route through the Dominican Republic.
